Renting A Home (From the North Carolina Department of Justice)

If you decide to rent a house or apartment, keep in mind that both tenants and landlords have rights and responsibilities under the law. By law, your landlord is required to keep your unit in good and safe working order and to follow relevant state and local codes.

To understand how to deal with landlord-tenant disputes, consider these tips:

When you discover that something needs to be fixed, ask to have it repaired. Let your landlord know about the problem immediately over the telephone or in person but follow up with a written request and keep a copy of it for vourself.

If your landlord doesn't respond in a reasonable amount of time, you may decide to pay to repair an emergency problem yourself. Be sure to keep copies of all receipts so that you can seek reimbursement from the landlord.

Don't withhold rent to convince your landlord to make repairs. Instead, try to work out a cut in your rent. For example, the landlord may allow you to pay to fix a broken refrigerator and then subtract the cost from your next month's rent. Or, the landlord may agree to reduce your rent for a month during which you could not use one room because of a leaky roof. Continued on page 2...

If the landlord fails to fix something that puts your safety at risk or violates local codes, report it to local authorities. Local building, health, fire and safety inspectors can take action to ensure compliance with the codes.

If you and your landlord aren't able to settle your disputes, you may want to call the Attorney General's Consumer Protection Division at 1-877-5-NO-SCAM. While we cannot represent you in private legal matters and you may ultimately need to take your landlord to court to enforce the law, we may be able to assist you with your questions and help you to determine what your next steps might be.

You can also file an action in small claims court. You can do the repair yourself and then sue to be reimbursed for the costs or sue to withhold future rent ("rent recoupment") until you've recovered the costs. You can also sue before the problem is fixed and ask that the court allow you to withhold future rent to cover the costs ("rent abatement"). In either case, you may be able to recover damages for the cost of the repairs, the inconvenience and any damage to your personal property.

Even if you win in small claims court, the landlord will not be required to pay your attorney's fees. For this reason, you might consider pleading your case in small claims court without a lawyer.

To make your case in small claims court, you'll need to provide proof of the following: that you have a written or oral lease; that the landlord was required by law to fix the problem; that you gave written notice of the problem, if required; that the landlord failed to fix it within a reasonable time; that you paid to fix the problem or have an estimated cost to fix the problem; and that the problem reduced the rental value of the property.

Attorney General Josh Stein Reaches Settlement with Fast Food Chains to Protect Employees

RALEIGH, NC (March 13, 2019) -- Attorney General Josh Stein today announced a multistate settlement with four national fast food chains—Dunkin', Arby's, Five Guys, and Little Caesars—over an investigation into nopoach agreements that restrict the ability of fast food workers to move from one restaurant chain franchise to another. No-poach agreements hurt low-wage workers by limiting their ability to secure better-paying jobs. As a result of today's settlement, the four fast food chains will cease using them.

"I'm taking this action to stand up for fast food employees, who deserve to earn the full value of their work," said Attorney General Josh Stein. "No-poach agreements unfairly depress wages. I'm pleased to announce today's settlement, and I will continue to work to stamp them out."

Under the settlement, the four chains will:

- Stop including no-poach provisions in any of their franchise agreements.
- Stop enforcing any franchise agreements with these provisions already in place.
- Amend existing franchise agreements to remove nopoach provisions.
- Ask their franchisees to post notices in all locations to inform employees of the settlement.
- Notify the attorneys general if one of their franchisees tries to restrict any employee from moving to another location under an existing no-poach provision.

A coalition of 14 attorneys general, including Attorney General Stein, began their investigation in July 2018 into Arby's, Burger King, Dunkin' Brands, Five Guys Burgers and Fries, Little Caesars, Panera Bread, Popeyes Louisiana Kitchen, and Wendy's. The attorneys general alleged that no-poach provisions, which many employees are unaware exist, make it difficult for them to improve their earning potential by moving from one job to another or seeking a higher-paying job at another franchise location.

Since the investigation began, Wendy's provided confirmation that it never used no-poach provisions in franchisee contracts. Investigations continue into Burger King, Popeyes, and Panera.

Caldwell Journal Weekly Recipe

Tex Mex Zucchini Lasagna

Ingredients

kosher salt
1/2 lb. lasagna noodles
1 tsp. extra-virgin olive oil, plus more for drizzling
2 cloves garlic, minced
1 small onion, chopped
1/2 tsp. cumin
1 10-oz. can enchilada sauce
1 14-oz. can crushed tomatoes
1/4 c. freshly chopped parsley, plus more for garnish
1 lb. sliced Pepper Jack
2 large zucchinis, thinly sliced
16 oz. whole-milk ricotta

Instructions

Preheat oven to 375°. In a large pot of salted boiling water, cook pasta according to package directions until al dente, less 2 minutes. Drain and drizzle with olive oil to prevent noodles from sticking together.

Meanwhile, in a large pot over medium-high heat, heat 1 teaspoon olive oil. Add garlic, onions, cumin, and salt and stir, 3 to 4 minutes. Add enchilada sauce, tomatoes and parsley, and stir until warmed through, then turn off heat.

In a large casserole dish, spread a thin layer of sauce, a single layer of lasagna noodles, a single layer of pepper jack, a single layer of zucchini, and a layer of ricotta mixture; repeat layers. Top last layer of noodles with zucchini and pepper jack.

Cover with foil and bake, 15 minutes, then increase temperature to 400° and bake uncovered for 20 minutes. Garnish with parsley and serve.

NCFB Hurricane Relief Fund Spring Pasture Renovation Seed Initiative – Now Accepting Applications

LENOIR, NC by Seth Nagy (March 10, 2019) -- North Carolina farmers have been hit hard with recent hurricanes and record-breaking rains. To help farmers across North Carolina, the NC Farm Bureau established the Hurricane Relief Fund. The Hurricane Relief Fund helped eastern NC farmers replant pastures this past fall. Now, Caldwell County is included in the latest recovery effort of the Hurricane Relief Fund. It is called the Spring Pasture Renovation Seed Initiative. The goal of this program is to replenish lost forage and keep productive soils from washing out of the fields.

This program is offering summer annual and perennial seed to farmers to renovate damaged pastures. Producers in Caldwell County with pastures impacted by Hurricane Florence and Tropical Storm Michael are eligible to request seed. Seed will be available for pick up at designated locations. The closest locations to Caldwell County are Taylorsville and Wilkesboro. Producers will be notified by email regarding the day they can pick up seed. Planting costs and associated labor are the responsibility of the farmer and will not be reimbursed.

Each applicant from Caldwell County is eligible for up to \$500 in seed. The maximum amount depends on acreage and availability. There are five species of seed available in this program.

These are Gaucho Bermuda, MoJo Crabgrass, TifQuick Bahiagrass, Sorghum Sudangrass, and Millet.

Good choices for Caldwell cattlemen are Gaucho Bermuda, MoJo Crabgrass, Sorghum Sudangrass, and Millet.

MoJo Crabgrass is an improved variety of crabgrass. It grows taller and produces more forage than volunteer crabgrass. Crabgrass is very palatable to grazing animals. It is a good safe choice for cattle, horse, and goat producers. In controlled experiments steers grazing crabgrass have gained over 3 pounds per day. (credit University of Arkansas)

The Gaucho Bermuda and MoJo Crabgrass will both come back reliably each year. The Sorghum Sudangrass and Millet are good choices for those wanting to replant to a cool season grass like tall fescue or orchardgrass.

Horse owners should avoid Sorghum Sudangrass. Forages in the Sorghum family can cause horses to have an inflammation of the bladder, a condition called cystitis. This can lead to urinary disorders, lack of coordination, and paralysis in severe cases. The other choices are all safe for horses, ponies, donkeys, and mules.

Interested producers can submit an online application. The Foundation will be accepting applications until 9 a.m. on March 17, 2019. Producers will be notified by April 1 as to the status of their application. Blue Ridge Energy Members Helping "Beat The Peak"

LENOIR, NC (March 6, 2019) -- The combined efforts of Blue Ridge Energy members and the cooperative's other electric demand reduction programs have generated power cost savings approaching half a million dollars.

"Currently, 4,075 households are responding to Beat The Peak alerts to shift the times they use the most electricity from peak usage periods to other times, said Renee Whitener, director of public relations for Blue Ridge Energy. This is helping the cooperative's overall efforts to hold down wholesale power cost—the most significant expense for the cooperative," she said.

Peaks in electricity usage typically occur for two to three hours on the coldest winter mornings when people are getting ready for work and school, and the hottest summer afternoons when the most air conditioning is being used. Simple steps can help Beat The Peak! Examples are: adjusting thermostats by a few degrees, delaying laundry and dishwashers, and turning off unnecessary lights.

"Since wholesale power cost is the single largest utility expense, efforts to reduce this cost benefit members by helping hold down rates," Whitener continued. "We appreciate the Beat The Peak volunteers and are encouraging more participation for even greater savings in 2019."

Members can sign up for Beat The Peak online at BlueRidgeEnergy.com/BTP to receive their choice of text, phone or emails alerts. Or text BTP to 70216 to receive text alerts. Members can also download the Blue Ridge Energy mobile app and enable notifications.

"Please tell a family member, neighbor, and friends to sign up for Beat The Peak," said Whitener. "Every action helps to shift the use of electricity during peak periods. Together, we can keep costs lower to benefit members." she summed up.

First Graduating Class of Caldwell Youth Leadership



ASHEVILLE, NC (March 12, 2019) -- The National Park Service invites the public to attend its upcoming Blue Ridge Parkway Season Preview, an open house style event highlighting Parkway activities and upcoming projects. The Parkway is hosting two Season Preview events this year. The first Season Preview will be held at the American Legion building in Blowing Rock, North Carolina on April 3, 2019. The second event will be held on April 4, 2019 at the Virginia Horse Center in Lexington, Virginia. The goal of these events is to promote awareness and understanding among Parkway communities, neighbors and visitors of the National Park Service's stewardship mission.

National Park Service staff will be on hand at each event to provide a "behind the scenes" look into the Parkway. The events will highlight over 20 information stations with park staff and partners at each station to answer questions and discuss upcoming projects.
