



Caldwell County Public Information Officer LouAnne Kincaid passes away

LENOIR, NC (March 26, 2018) -- LouAnne Kincaid, Public Information Officer for Caldwell County, has passed away after a brief bought of pneumonia.

For over thirty years, LouAnne Kincaid has brought the news to the Catawba Valley.

Starting her career out of college as News Anchor for WHKY-TV14 in Hickory, North Carolina in 1989, she quickly established herself as top notch reporter. She asked the questions that the viewers at home wanted the answers to.



While at WHKY she was hired to be a "String Reporter" for WBTV News Channel 3 in Charlotte, North Carolina, where she covered the greater Hickory Metro area for the Charlotte TV audience. In 1994 WBTV took her on as a full time reporter and she covered various stories across their large viewing area.

After tiring of the daily grind of nightly news, she went to work for Catawba Valley Community College in 2000. In the marketing department of CVCC, she told folks about the college and all that it had to offer new students of all ages.

In the 2009 she took on the role of Caldwell County Public Information Officer. While writing news about the county, she began hosting TV shows on the Caldwell County Government Channel 190. Soon a familiar face was back on local television, talking to folks about the Health Department, the Department of Social Services, Emergency Services and all of the departments across the county while also highlighting non-profit services too.

During her tenure as Public Information Officer, LouAnne over saw several changes to the county, including the formation of employee customer service training, an upgrade of the City-County Chambers for better broadcast of local meetings and a total refit of the CCGTV Studio.

LouAnne Kincaid is survived by her mother Marylou Kincaid and her brother Jim Kincaid. She was 56 years old.

A receiving of friends will be at Evans Funeral Home and Crematory, Sunday, March 31st from 1:30 pm to 3:00 pm followed by a memorial service with Pastor Doug Price officiating. Interment will follow the service at Littlejohn's Methodist Church in Gamewell. A Caldwell County Release

Caldwell Journal Weekly Recipe Meatball Subs

Ingredients

1/2 c. diced celery 1/2 c. diced carrots 1/2 c. diced onion 2 cloves garlic, minced 1 c. freshly chopped parsley 3/4 c. bread crumbs 1/2 c. freshly grated Parmesan, divided 1 large egg 2 tbsp. ketchup Kosher salt Freshly ground black pepper 1 lb. ground beef 1/2 lb. ground pork 4 hero rolls, sliced lengthwise 1 c. marinara

Instructions

1 c. shredded mozzarella

Preheat oven to 400°. In a large bowl, mix together celery, carrots, onions, garlic, parsley, bread crumbs, 1/4 cup Parmesan, egg, and ketchup and season with salt and pepper until well combined. Add beef and pork, mixing together by hand until just combined (don't over mix to maintain tender meatballs). Form 1 1/2" meatballs and place in an oven-safe dish or baking sheet. Do not overcrowd.

Bake until meatballs are browned and no longer pink, 20 minutes.

Meanwhile, toast rolls and warm marinara in a small saucepan. Spoon marinara over meatballs and top with mozzarella. Return to oven until cheese is melty.

Place meatballs in toasted hero rolls and sprinkle with remaining 1/4 cup Parmesan before serving.

Two individuals arrested for breaking into the Granite Falls State Employees Credit Union

GRANITE FALLS, NC (March 21, 2019) -- The Granite Falls Police Department arrested two individuals for breaking in the State Employees Credit Union overnight.

On Thursday, March 21, 2019 at approximately 4:30pm, Andrew Claude Stahl, 35, of Lovelady Lane Granite Falls and Mathew Nathaniel Glenn, 20, of Faith Lane, Hudson were arrested for felony breaking and entering after Granite Falls Police found a broken window at the State Employees Credit Union located at 145 North Highland Avenue at 4:47am this morning. An officer, along with a Hudson Police officer, responded to the bank after an alarm was called in to the Police Department. While at the bank, the officers located the broken window. No one was located at the scene at the time of the alarm.

Investigators from the Police Department obtained video footage from the bank. A description of a vehicle and person were obtained from the video.

While on patrol, Lt. Ricky Gilliland observed a vehicle matching the one in the video traveling on Falls Avenue. Lt. Gilliland stopped the vehicle and identified Andrew and Mathew in the vehicle. Officers discovered there were warrants on Andrew out of Catawba County. During a search of the vehicle there were several items found that were used in the breaking and entering.

In addition to the felony breaking and entering charges, Andrew and Mathew were charged with possession of burglary tools. Andrews bond is a combined \$30,000 secured, adding in the true bill of indictment for breaking, entering and larceny from Catawba County. Mathew's bond is \$20,000 secured. Both were incarcerated in the Caldwell County Detention Center and have a first appearance in District Court in Lenoir on March 25, 2019. Additional charges are anticipated. Nothing was taken from the bank.

Traffic stop leads to drug related arrest

LENOIR, NC (March 20, 2019) -- On March 19th, 2019 at 2:09 pm the Lenoir Police Department's Narcotics Unit along with a Lenoir Police Department K-9 unit stopped a gray 1994 Infinity on Scroggs Ave. near Main Street. The reason for the initial stop was a seatbelt violation. The person driving the vehicle was Jordan Fredrick. During the course of the investigation the vehicle was searched. The officers located 9.5 grams of crack cocaine and 2.0 grams of heroin inside the center console of the car. Later, 21.7 grams of methamphetamine was found inside Fredrick's pocketbook. According to North Carolina State guidelines, the seized drugs were valued at \$5,405.00. Officers also seized \$214.00 in US currency.

Jordan Fredrick was arrested at the scene and charged with 1 count of Felony Possession with Intent to Manufacture, Sell, or Deliver Methamphetamine, 1 count of Felony Possession with Intent to Manufacture, Sell, or Deliver Cocaine, 1 ct. Felony Possession with Intent to Manufacture, Sell, or Deliver Heroin, and 1 ct. Felony Maintaining a Dwelling or Vehicle for the Purpose of Controlled Substance. Fredrick received a \$250,000.00 secured bond and an initial court date of 03/20/2019. More charges may be forthcoming. Narcotic Agents Take Down Another Meth Dealer

LENOIR, NC (March 19, 2019) -- Sheriff Alan C. Jones has announced on March 19, 2019, Agents with the Caldwell County Sheriff's Office Ice Unit concluded a month-long investigation into suspected methamphetamine dealer, Jeremy Curtis Setzer, age 33, of 1923 Norwood St. #304 Lenoir, North Carolina.

The investigation came to an end on March 18, 2019 with an arrest in the parking area of a retail establishment on Hickory Boulevard in Granite Falls. Agents placed Jeremy Curtis Setzer and Destinee Kay Smith, age 22, of 3043 1st Ave. NW Hickory, North Carolina in custody. Agents seized a total amount of 84 grams of methamphetamine from Setzer and Smith during the investigation.

Jeremy Curtis Setzer has been charged with one count of Trafficking Methamphetamine by Possession, one count of Trafficking Methamphetamine by Transport and one count of Maintaining a Vehicle for the Sale of Controlled Substance. His bond was set at \$100,000.00 secured and his first appearance is set for March 20, 2019. Setzer is also currently on Parole for Conspiracy to Manufacture Methamphetamine.

Destinee Kay Smith has been charged with one count of Trafficking Methamphetamine by Possession, one count of Trafficking Methamphetamine by Transport and Maintaining a Vehicle for the Sale of Controlled Substance. Her bond was set at \$30,000.00 secured and her first appearance is set for March 20, 2019.

Don't be fooled by imposter scams

RALEIGH, NC by Attorney General Josh Stein (March 21, 2019) -- If someone contacts you to tell you that you're in trouble with law enforcement or the government, or someone you love is danger, it's understandable to feel panicked or afraid. It's also understandable to want to act immediately to fix the situation.

But fear and panic can make us vulnerable to scammers who want to steal our money. These scams are called imposter scams. In 2018, consumers reported more than 500,000 imposter scams to the FTC and lost nearly \$488 million as a result.

Many imposter scams involve people pretending to be government officials. Often, they pretend to be IRS agents or auditors, calling you to say that you owe taxes and will face legal consequences if you don't pay. They may also pretend to be from other government agencies, such as the Social Security Administration, threatening that your Social Security number is about to be suspended. Some scammers pretend to be local law enforcement or court officials, claiming that you've missed jury duty and are going to be arrested.

Sometimes, scammers will fake a family emergency or kidnapping to scare you into thinking that someone you love has been injured or is in immediate danger. They'll tell you that you must pay immediately to ensure your family member or loved one's safety.

These calls can be scary, but the most important thing is to not act right away when you're agitated. If someone calls you about a family member, hang up and contact other family members or people you trust to verify the claim. And remember — law enforcement and government officials will never call you to threaten you with arrest, and the Social Security Administration and IRS will never threaten to seize your finances over the phone.

Don't share any personal information with the caller – including your Social Security number, personal data, bank account or tax information, or any other identifying details. This is the information scammers use to access and steal your money or ruin your good name.

Do not respond to any requests for money, and never wire or send money in response to a phone call or email. And if they're asking for money through prepaid gift cards or debit cards, it's always a scam. Don't fall for it. Getting your money back is very rare.

Imposter scammers prey on our desire to stay safe and protect ourselves and our families. But in a panic, we may compromise our information and finances instead.

Always be suspicious of people who contact you out of the blue with a problem that can only be solved by sharing personal information or sending payment. Almost every time, these are scams, and you can avoid them by staying calm and not giving the scammers what they want. CCC&TI Early Childhood Education Program Hosts Film Screening

Team USA to Play Cuba at the Frans

HICKORY, NC (March 19, 2019) -- The Hickory Crawdads are thrilled to announce that LP Frans Stadium will play host to a game between the USA Baseball Collegiate National Team and the Cuban National Team on July 2nd. The game, presented by Big Dawg 92.1, KICKS 103.3, and WHKY 1290 AM and 102.3 FM, is set for 7pm and will feature a post-game fireworks show.

Tickets are on sale now for the matchup at hickorycrawdads.com. The Crawdads will have both concessions stands, the Catawba Farms Crawdads Café, and amusements open during the game.

This year will be the 8th Annual USA vs. Cuba International Friendship Series. After a 16-year hiatus, the two teams resumed the friendly series in 2013 with a fivegame series in Havana.
