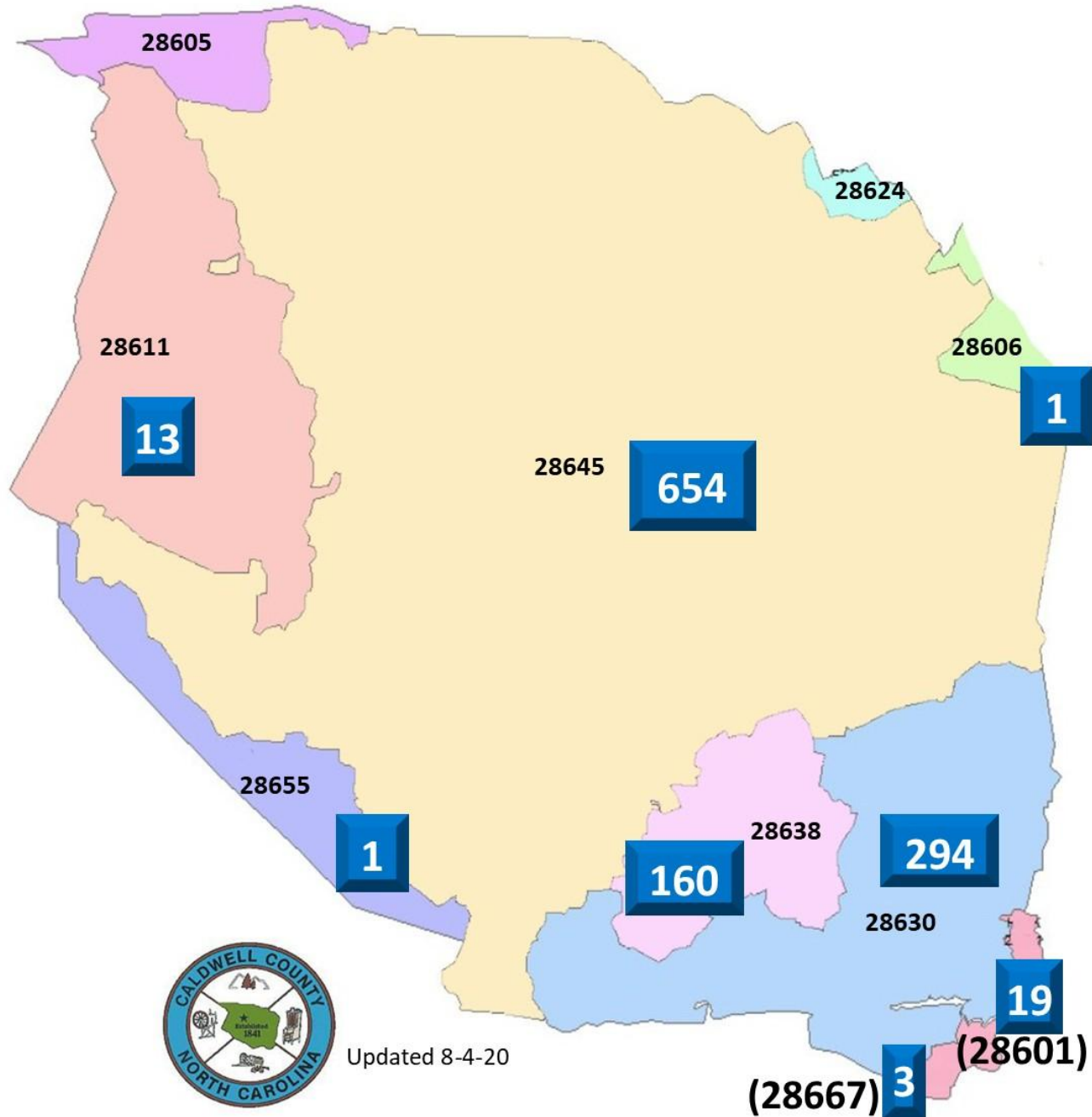

Current Outbreaks

In congregate living settings, an outbreak of COVID-19 is defined as two or more laboratory-confirmed cases within a 28-day period.

In order for an outbreak to be closed, the facility must test all negative patients weekly until they have two consecutive weeks without a positive test and 28 days have passed since the last confirmed positive case.

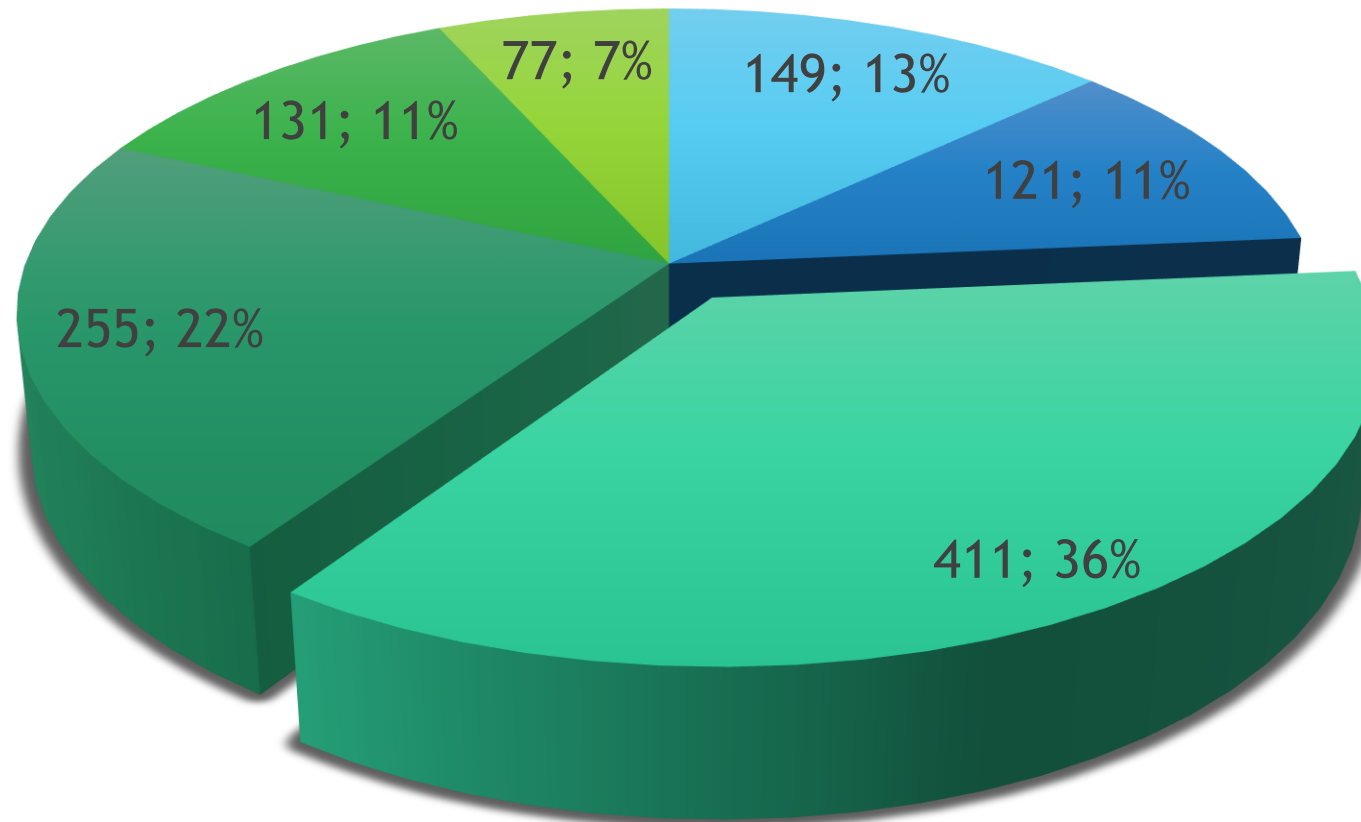

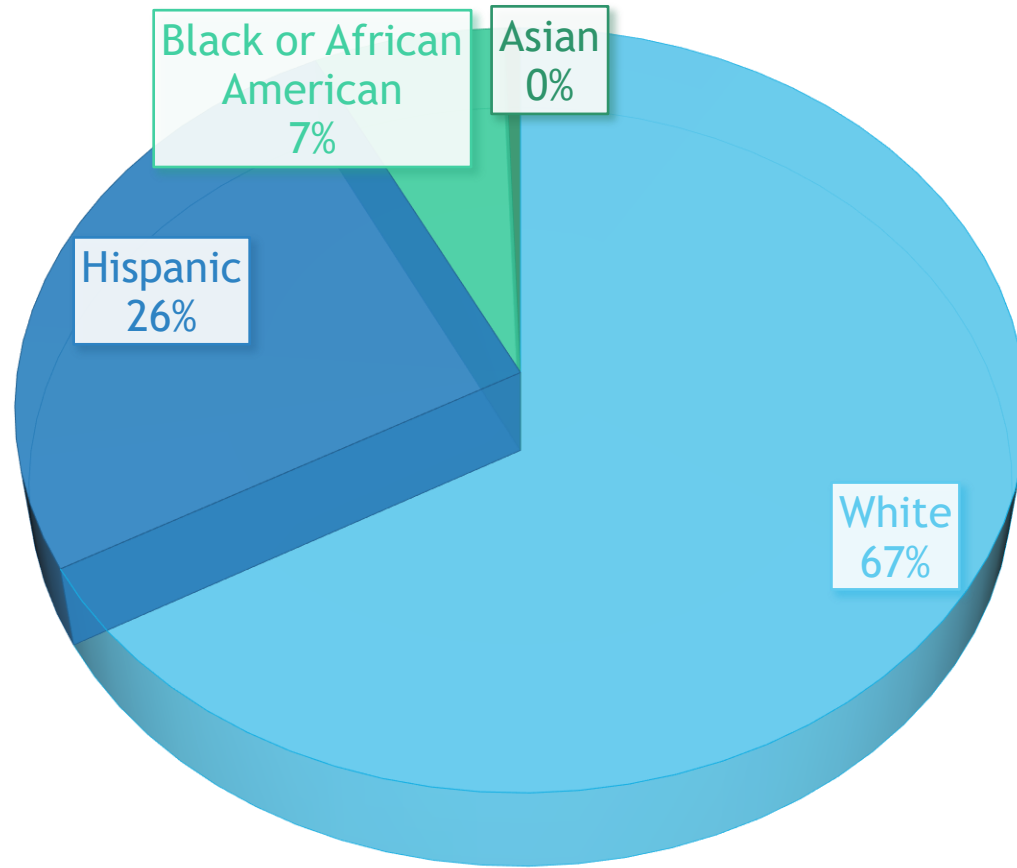
Cases by Zip Code

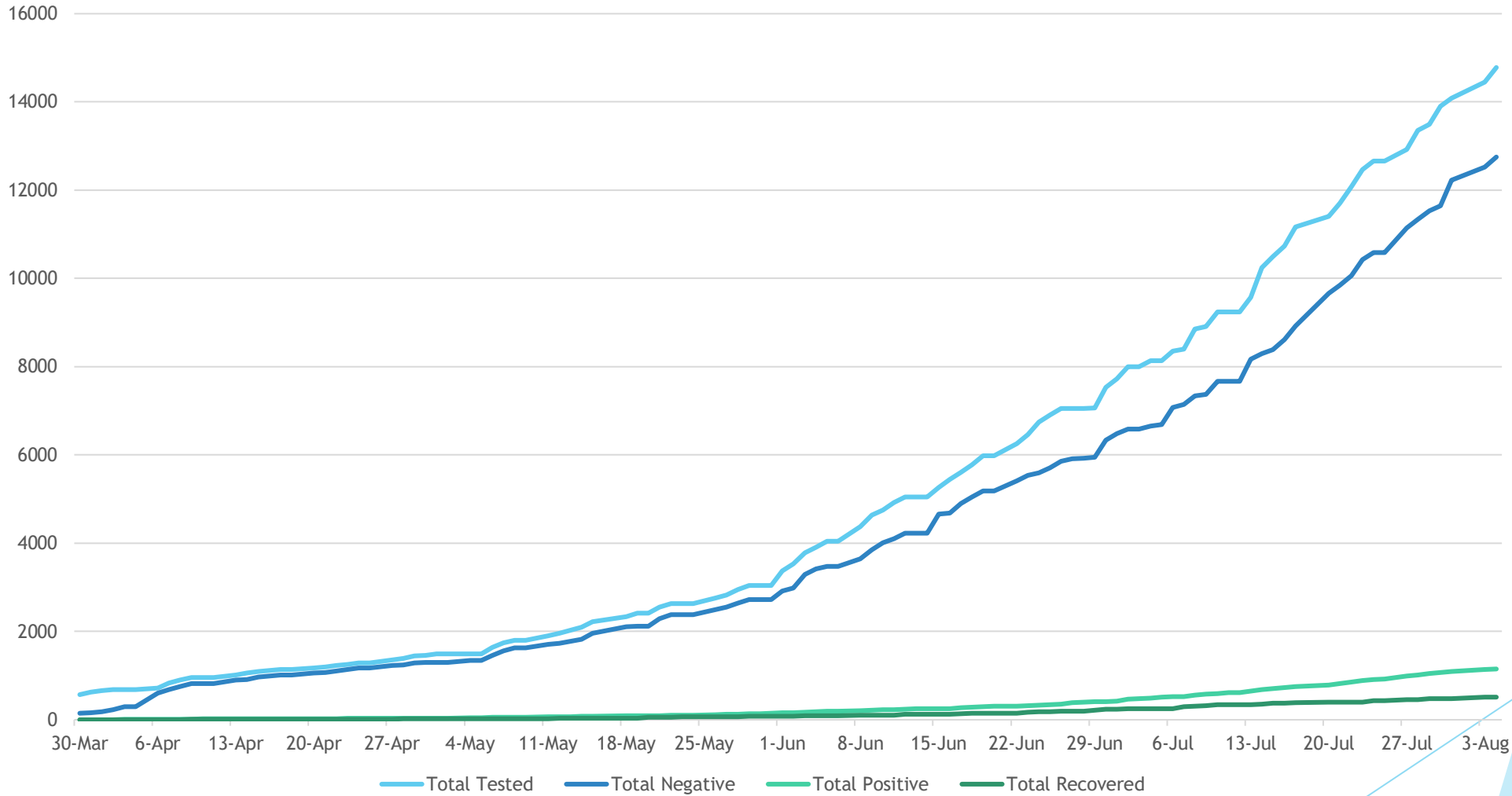

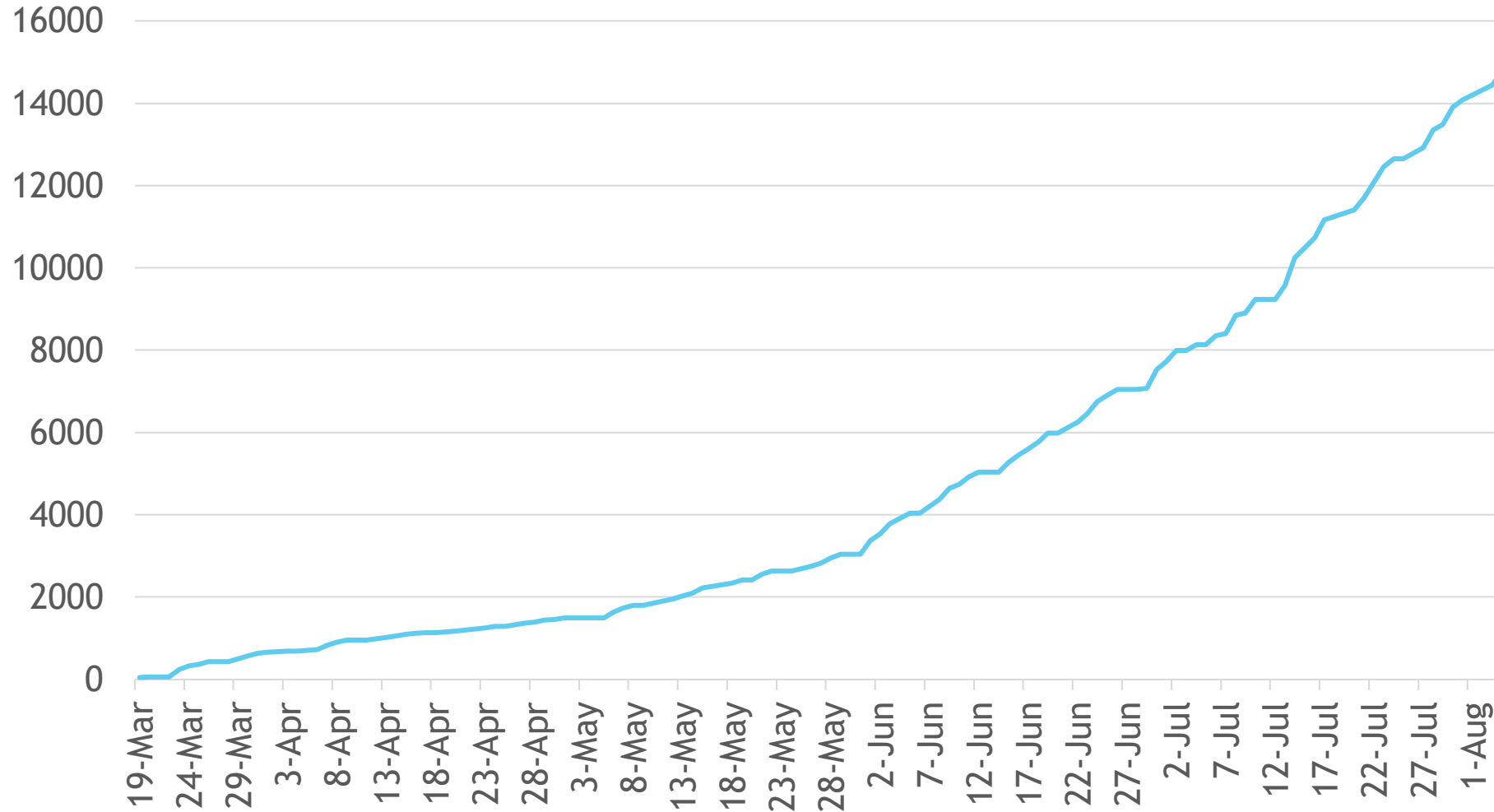

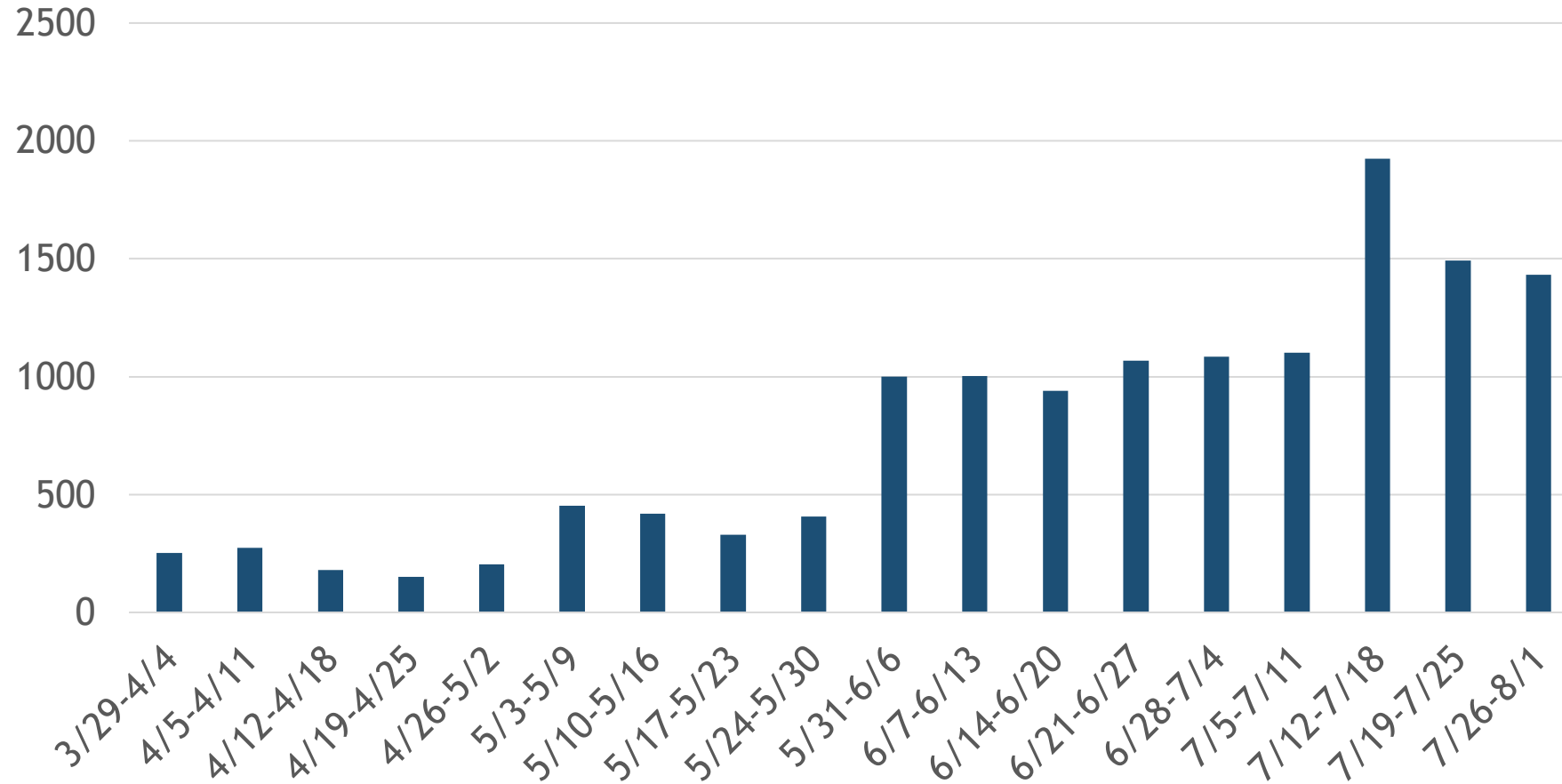
This chart compares the total number of tests conducted, total number of negatives reported, total number of positive patients, and the number of recovered patients.

Total Tests Conducted



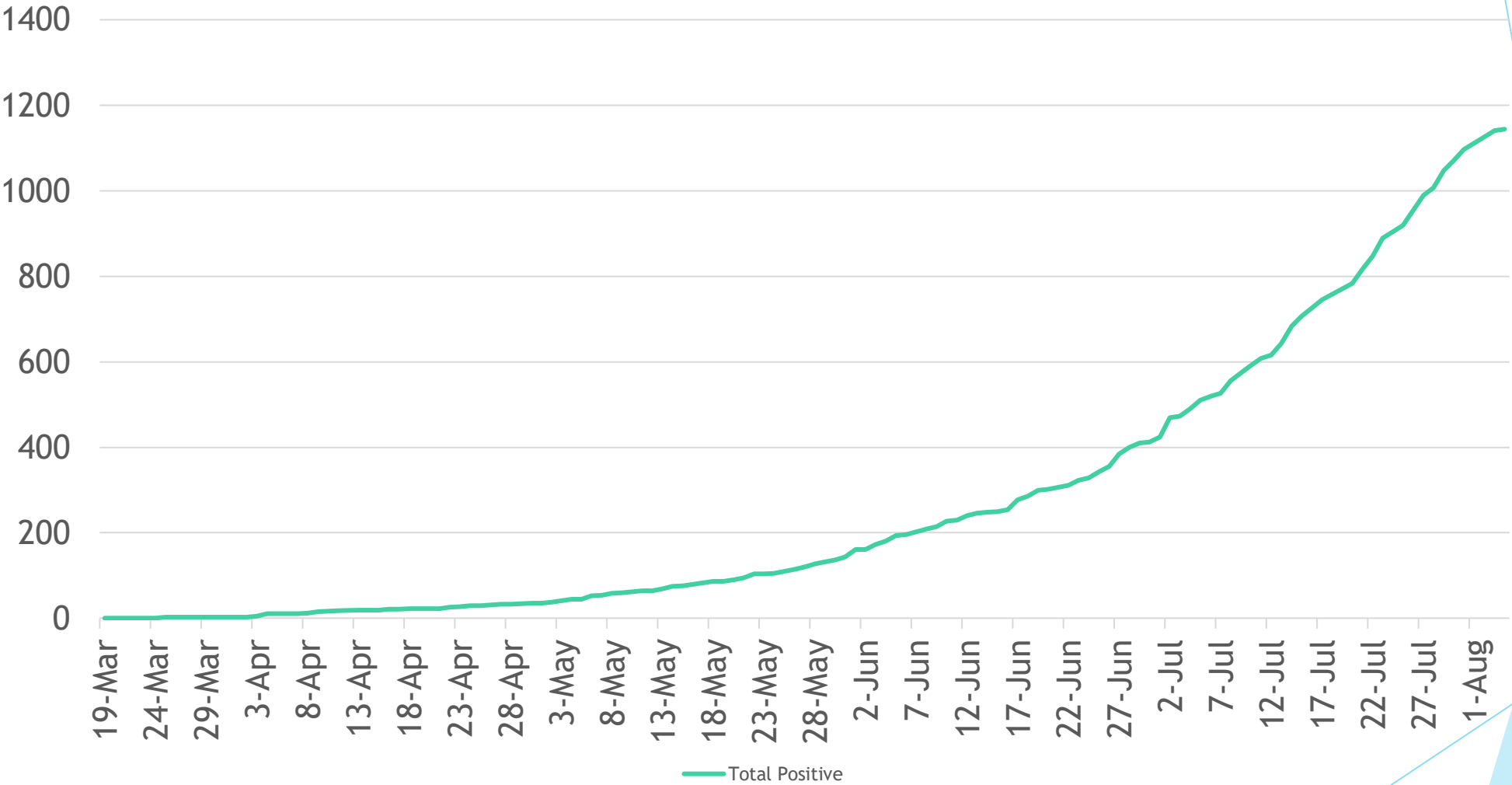

Tests Conducted Weekly



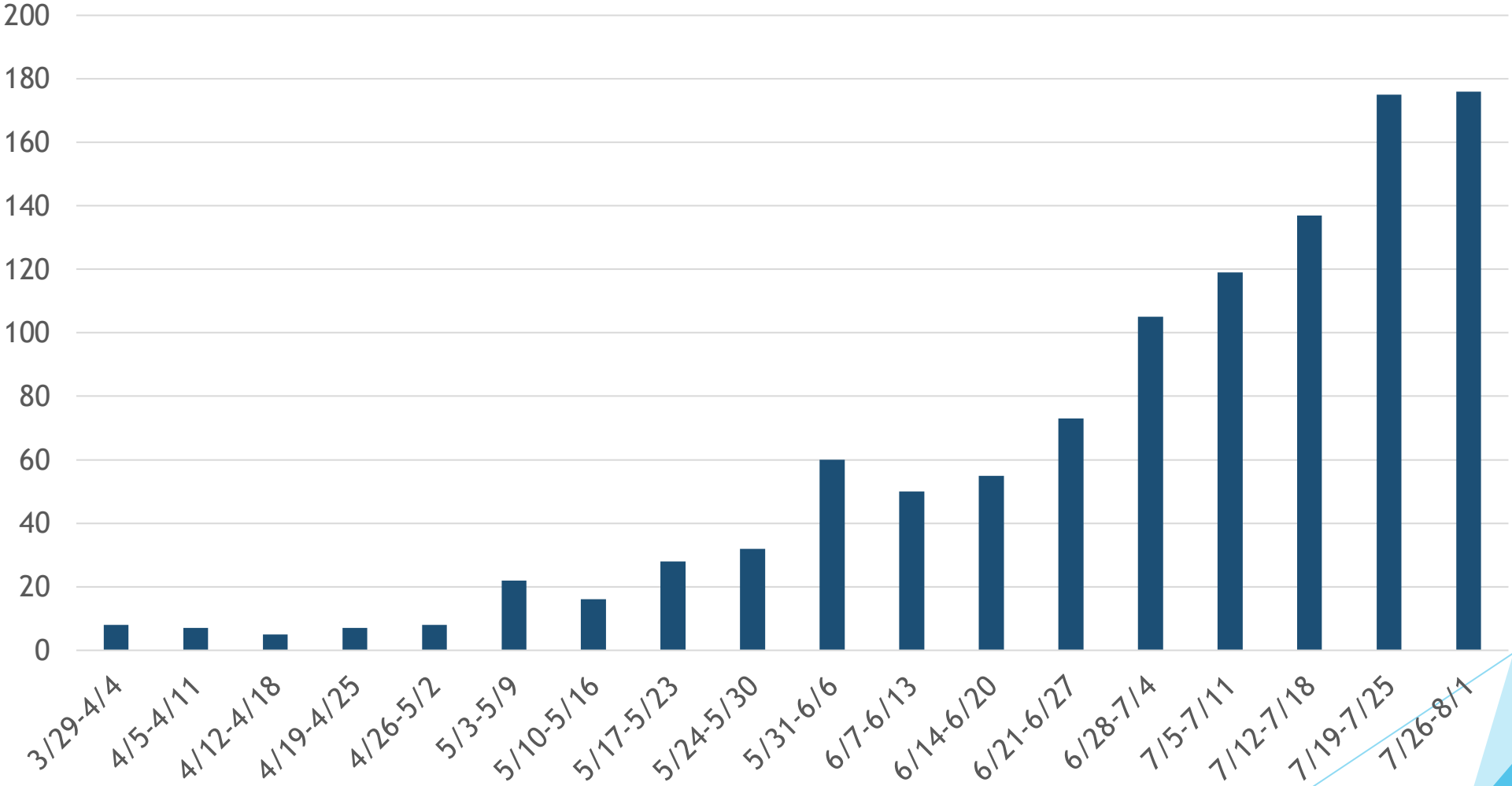
This chart shows the number of tests completed each week.

Positive Cases



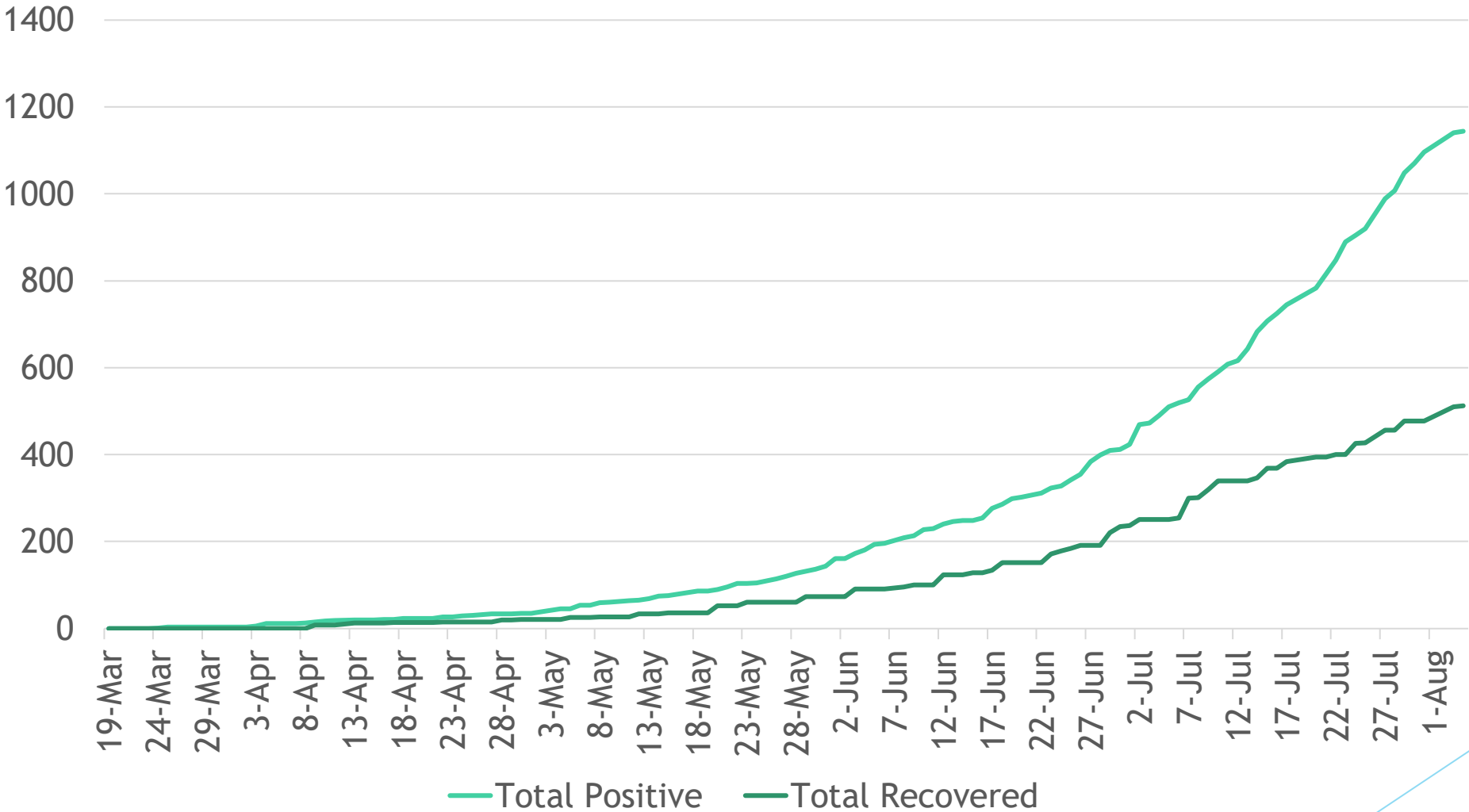
This chart shows the total number of positive patients in Caldwell County.

This chart shows the number of positive cases reported weekly.

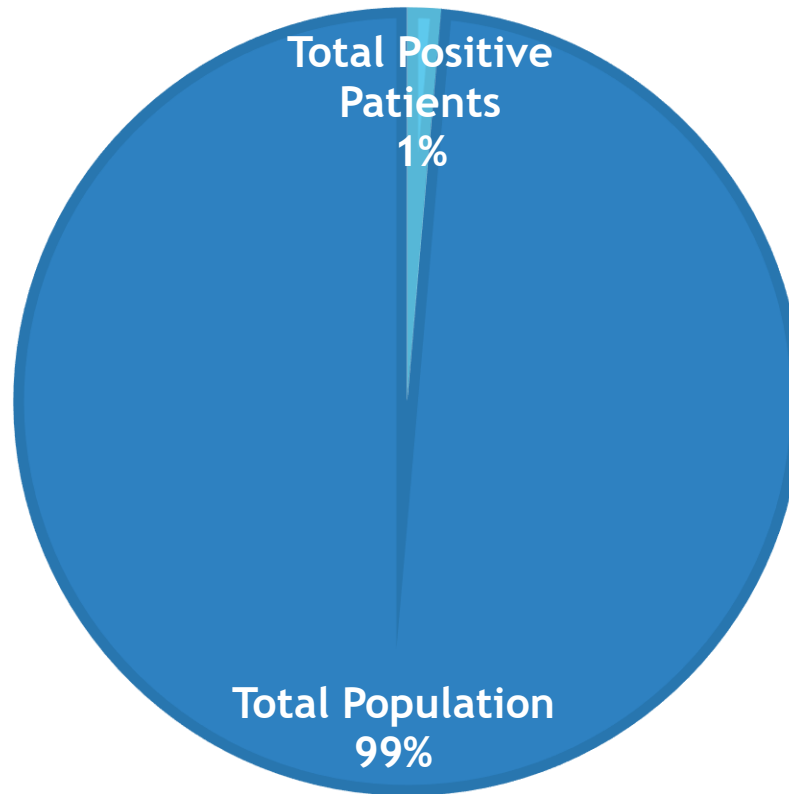
Total Positive and Recovered Patients



This chart compares the total number of positive patients with the number of recovered patients.

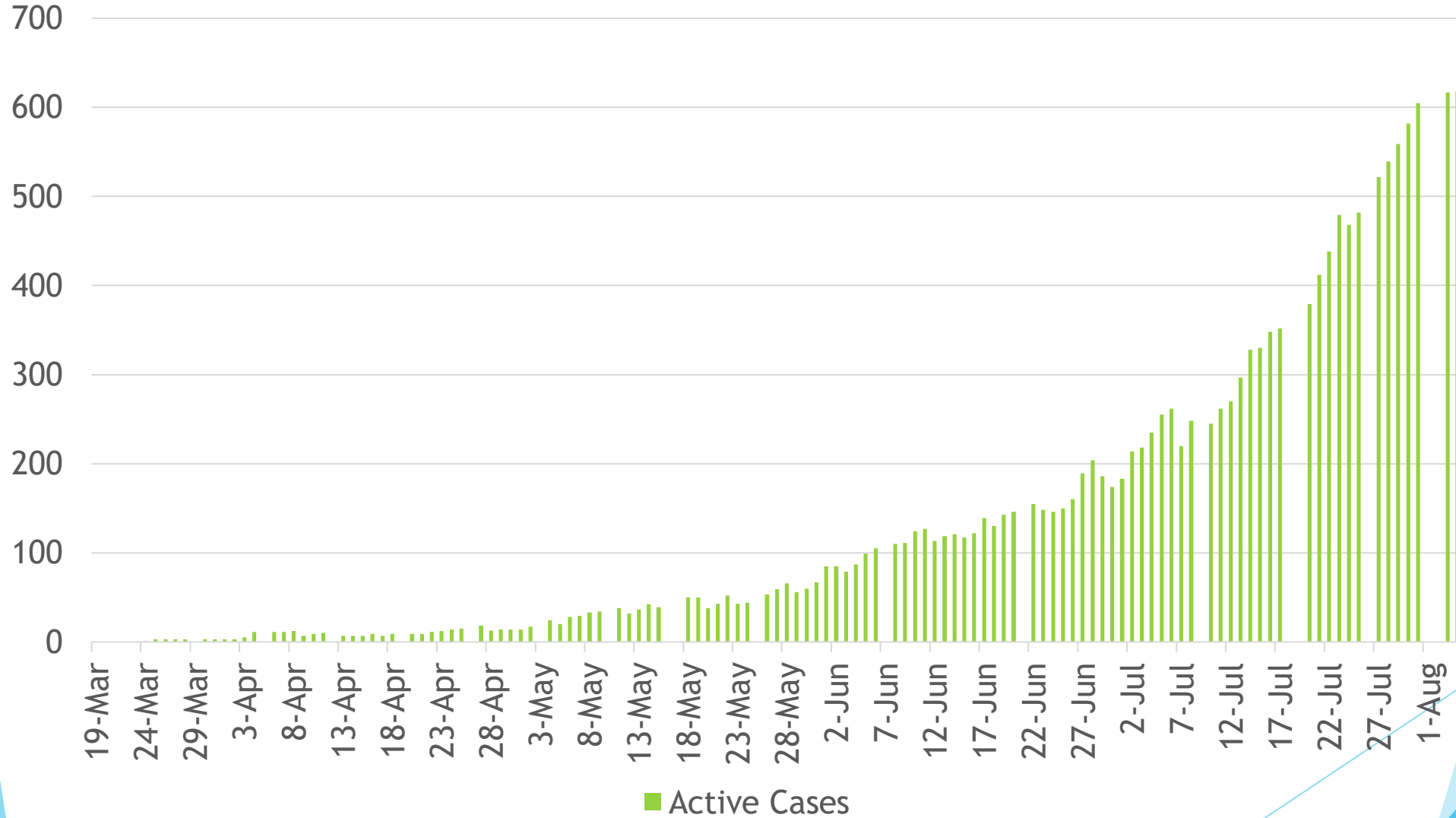
Total Positive Patients Compared to County Population

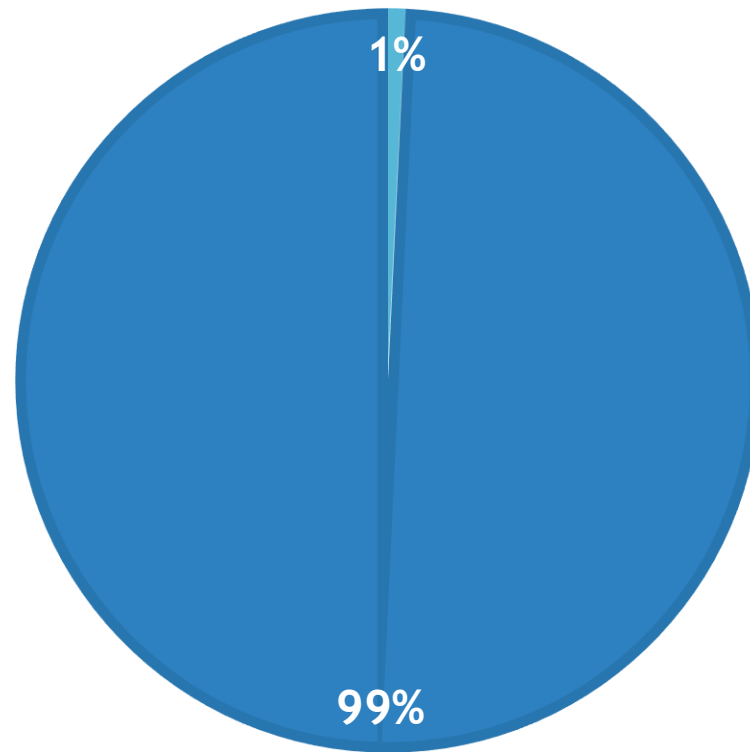
Active Cases



This chart shows the number of active COVID-19 cases per day in Caldwell County.

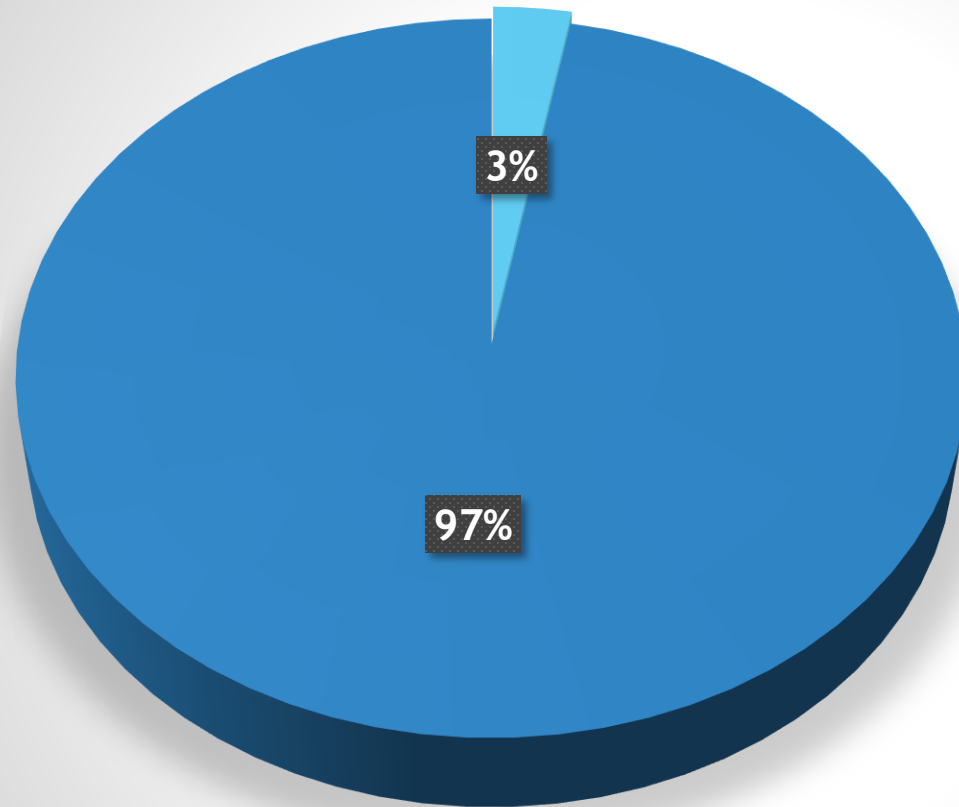
Active COVID-19 Patients Compared to County Population

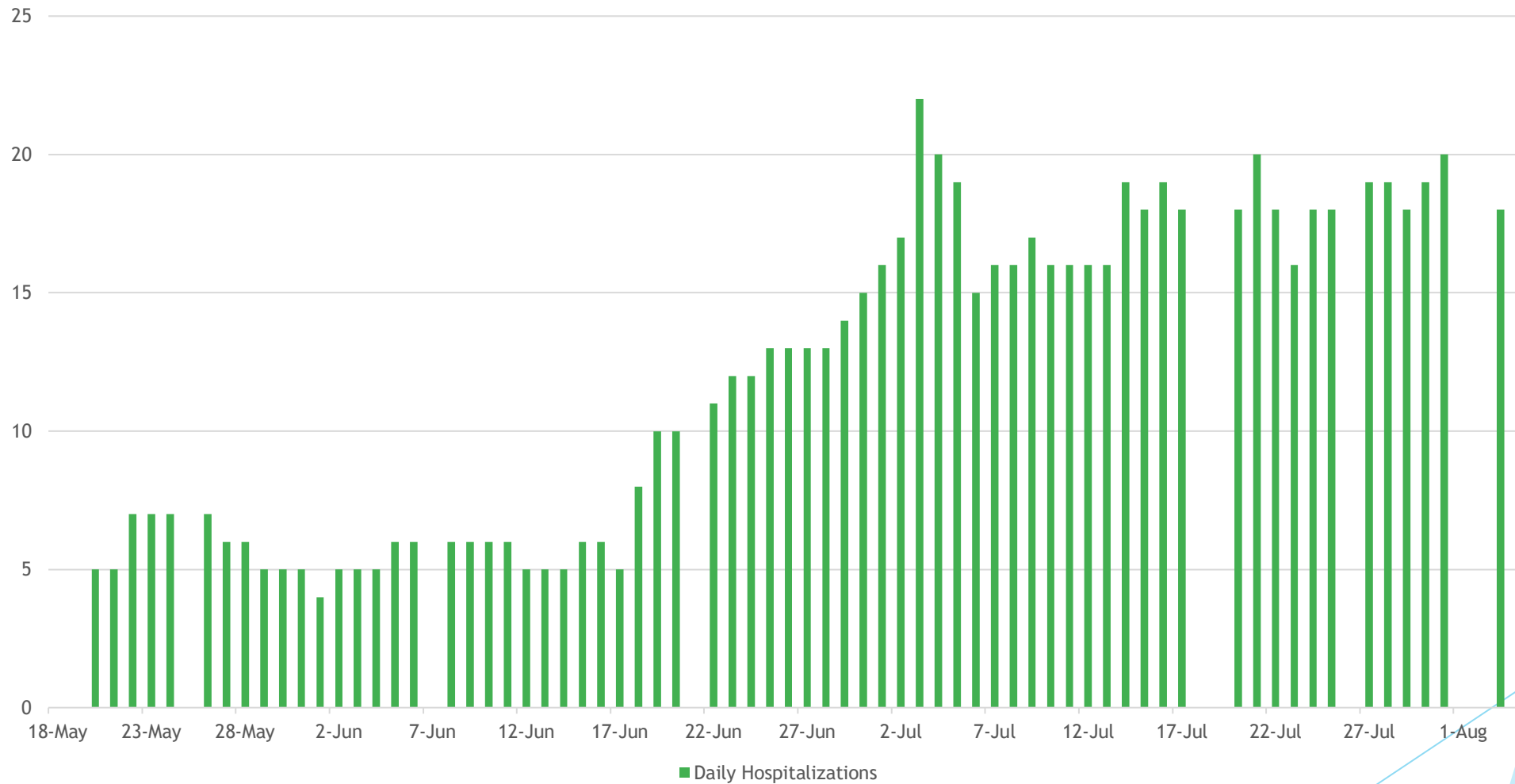
Hospitalizations

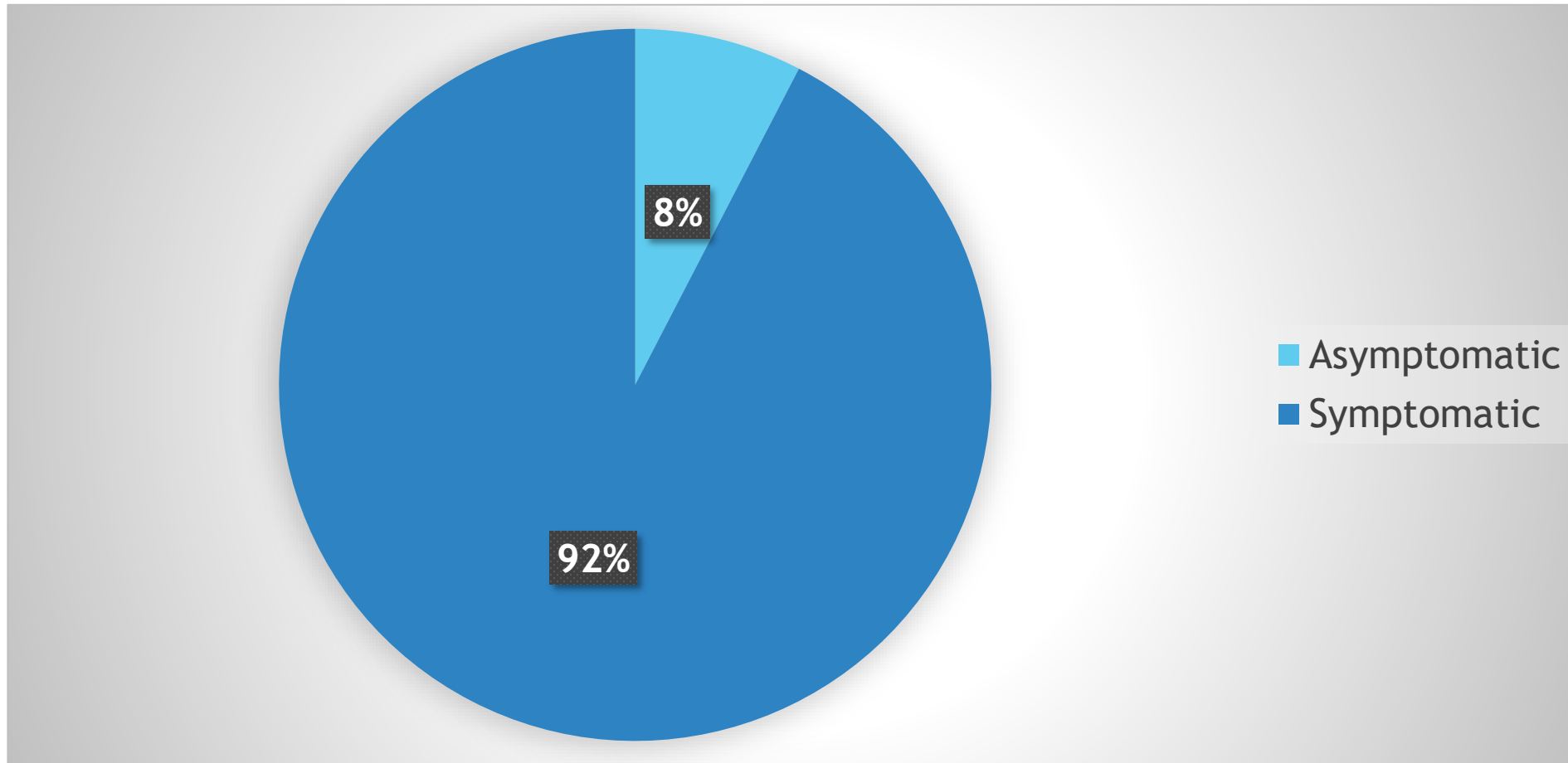
This chart compares the number of active positive patients who are hospitalized with the active patients who are not hospitalized.
